## **Guidelines for Special Issue Guest Editors**

We are delighted that you are acting as Guest Editor for an issue of **Paedagogica Historica** which is published by Taylor & Francis Ltd. If you have not acted in this capacity before, or are unfamiliar with the practices of Taylor & Francis, this overview of the publication process should help to ensure that the issue is published to time and to agreed criteria.

You will be contacted by a production editor when the manuscripts reach Taylor & Francis.

## **Deadlines**

We would like to emphasize that the publishing cycle is normally around 14 weeks, and that it is essential that the journal adheres to its allotted publication slot. Therefore, please ensure that you leave sufficient time for the review and revision of manuscripts. It often helps to give authors a deadline of at least three weeks before the actual final due date, and referees two weeks. When chasing for the final deadline, feel free to put the blame for the pressure on the publisher. When commissioning papers for the issue, it is helpful to have one or two as reserves in case an author cannot deliver on time.

### Editing

The Editor is responsible for the academic/scientific content and quality of the papers. The issue will be edited for style and format, and prepared for publication by a professional copy editor. Therefore, there is no need for you to spend time correcting the format of manuscripts. However, please check that each manuscript contains the following essential information:

- The full title of the article and a short title for use as a running head;
- The names, addresses, telephone number, and email addresses of all the authors and their affiliations;
- The name, address, telephone number, and email address of the corresponding author;
- A summary or abstract of approximately 100 to 200 words for the title-page of the article;
- The main body of text;
- The references, which should be presented according to the style given in the Journal's Instructions for Authors (<u>www.tandf.co.uk/journals</u>);
- Any tables and figures, which should be of a suitable quality for direct reproduction.

As a very rough guide to length, 2 manuscript pages or 500 words will make approximately 1 typeset page (depending on the journal style).

#### **Permissions and Copyright**

We require that authors obtain the necessary written permission in advance from any third party owners of copyright for the use in print and electronic formats of any of their text, illustrations, graphics, or other material, in their Article and in our Journal. The same applies to any other necessary consent. Taylor & Francis are signatories of and respect the spirit of the STM Agreement regarding the free sharing and dissemination of scholarly information. As such we partake in the reciprocal free exchange of material. Suggested wording for the request for permission is given below. It is also important to ensure you acknowledge the source in your figure captions, and cite the source in your Reference section.

## Permissions

#### Here is the advice to provide to authors of your special issue:

As an author, you are required to secure permission if you want to reproduce any figure, table, or extract from the text of another source.

This applies to direct reproduction as well as "derivative reproduction" (where you have created a new figure or table which derives substantially from a copyrighted source). Usually you will require the permission of both the author and publisher to reproduce this material.

If you are requesting permission from a library, archive, art gallery or museum, they will want to know the following information:

- publication medium: print or electronic
- title, author, publisher, approximate print run of the publication (i.e. how many copies will be printed)
- distribution rights requested, i.e. North American rights, world rights
- language rights requested (i.e. the language your article will be published in).

If you do not have this information, please contact the publishers and they can help you. You will need to allow several weeks for permission requests, so it is advisable to begin this process as early as possible.

The following sample letter can be used as a template in seeking permission:

#### Dear [COPYRIGHT HOLDER]

*I/we are preparing for publication an article entitled* [STATE TITLE] to be published by Taylor & Francis Ltd in the Paedagogica Historica

*I/we should be grateful if you would grant us permission to include the following materials: [STATE PAGE, FIGURE OR TABLE NUMBER AND ORIGINAL SOURCE]* 

We are requesting non-exclusive rights in this edition and in all print and electronic format in perpetuity. It is understood, of course, that full acknowledgment will be given to the source.

*Please note that Taylor & Francis are signatories of and respect the spirit of the STM Agreement regarding the free sharing and dissemination of scholarly information.* 

Your prompt consideration of this request would be greatly appreciated.

## Copyright

#### All authors will be asked to sign a copyright transfer agreement with Taylor & Francis.

The transfer of copyright is standard practice in serials and journals publishing. It is designed to facilitate the protection from copyright abuse for authors, editors, and publishers involved in the creation of a single copyright product composed of multiple contributions.

Taylor & Francis, in common with the majority of journal publishers, be they commercial or nonprofit, prefer authors to assign to Taylor & Francis or the Journal proprietor (such as a learned society for whom we publish) the copyright, in all forms, of papers accepted for publication in our Journals. Our rationale is as follows:

(i) Ownership of copyright by Taylor & Francis ensures maximum international protection against infringement, libel, abuse of moral rights or plagiarism.

(ii) It enables Taylor & Francis to deal efficiently with requests from third parties to reproduce, reprint, or translate an article, in full or part, and in accordance with a general policy which is sensitive both to any relevant changes in international copyright law and to the general desirability of encouraging the dissemination of knowledge. Notwithstanding this, we shall use all reasonable endeavours to ensure that any direct request to reprint an author's contribution, or a part of it, for example, figures, tables or illustrations, in another publication is approved by the Author prior to permission being given.

An increasing number of journals are now published in an electronic or digital edition. In addition to publication of an author's article in conventional printed form, an author's assignment of copyright also signifies their agreement to its publication and/or storage electronically or digitally. The Journal may also arrange to include an author's article in electronic or digital document-delivery services and databases.
